SAMPLE FORMAT FOR THE ARTICLES
OF ORGANIZATION OF A LIMITED LIABILITY COMPANY

(NOTE: THIS IS ONLY A SPECIMEN. YOU MUST DRAFT YOUR OWN DOCUMENT. DO NOT SIMPLY FILL IN THIS SPECIMEN. ARTICLES OF ORGANIZATION MUST CONTAIN AT LEAST THE INFORMATION SPECIFICALLY DESIGNATED BELOW AS A MINIMUM REQUIREMENT. ADDITIONAL PROVISIONS MAY BE INCLUDED REGARDING THE AFFAIRS OF THE COMPANY AND THE CONDUCT OF ITS BUSINESS TO THE EXTENT CONSISTENT WITH THE LAWS OF THE DISTRICT.)

ARTICLES OF ORGANIZATION

Pursuant to Title 29, Chapter 10 of the District of Columbia Code (the D.C. Limited Liability Company Act of 1994), the organize(s) named below adopt the following Articles of Organization:
